Draw Terms and Conditions:

1. Entries received after the 29th November will not be accepted.
2. Donations to crowd funder after the 29th November will be accepted, but will not be entitled the donor to entry into the prize draw.
3. Surfing England will not accept responsibility for entries that are lost, mislaid, damaged, or delayed in transit, regardless of cause, including, for example, as a result of any postal failure, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind.
4. By submitting an entry, you are agreeing to be bound by these Terms and Conditions.
5. Surfing England reserves the right to refuse entry, or refuse to award the prize to anyone, or to anyone in breach of these terms and conditions.

Eligibility

6. Unless otherwise stated, our prize draw is open to all except employees of Surfing England, their families, agents or any third party directly associated with administration of the prize draw.
7. Entrants under 18 must get consent from their parent(s) or legal guardian(s) before entering. The parent(s) or legal guardian(s) of entrants under 18 agree to these Terms and Conditions on behalf of the entrant.
8. One entry into the prize draw will be submitted for every £20 donated by the entrant

The Draw

12. A winner will be chosen by random draw performed by a computer or manual (names in hat) process within one week of the prize draw closing.
13. The winner will be notified by email, social media or telephone (using details provided at entry) within 7 days of being chosen and must provide a postal address to claim their prize,

or be able to pick up from the specified location. If a winner does not respond to Surfing England within 14 days of being notified, then the winner's prize will be forfeited, and Surfing England will be entitled to select another winner in accordance with the process described above.

14. The prize is non-exchangeable, non-transferable and no cash alternative is offered. Surfing England reserves the right to replace the prize with an alternative prize of equal or higher value if circumstances beyond Surfing England's control makes it necessary to do so.
15. The decision of Surfing England regarding any aspect of the prize draw or competition is final and binding and no correspondence will be entered into about it.
16. Surfing England reserves the right to hold, void, cancel, suspend, or amend the promotion where it becomes necessary to do so.

Limitation of liability
