

## Volunteer awards Terms & Conditions

- For the purposes of these Terms and Conditions, "The Promoter" refers to Surfing England whose Instagram handle is @Surfingengland.
- The "main sponsor" refers to Ocean Saver Ltd (Nos 3 Park Square East, Leeds, LS1 2NE) as the competition main sponsors
- The "Prize" refers to Prize bundles which include contributions by companies other than the main sponsor (e.g.TBC).
- By entering the competition, you agree to be bound by these terms and conditions. All entries must be received by 10a.m. on 2<sup>nd</sup> December 2024.
